

5 Days of Knight Camp – summer 2016

Kids day camp for August 22nd - August 26th, 2016 Ages first grade through age 12.



Before and after care are available for an additional fee - see details below.

Camp must be pre-registered so we can purchase camp materials. There are no refunds however arrangements can be made to transfer registration to a different child.

Our program is focused on teaching historical arts connected to the martial culture of Europe in the time of the crusades and beyond to the 16th century. We teach history and real world skills related to the time and culture of Knighthood.

Learn about European History and culture
Play medieval board games
Learn swordplay and self defense skill from surviving historical texts
Learn heraldry and design your own coat of arms and shield
Learn metalworking skills and make your own project
Learn about the knightly virtues of chivalry

Children will train with lightweight sword simulators and safety gear. They will have the opportunity to handle steel replicas of the real thing. All under the supervision of our instructors.

REQUIRED GEAR: Students will need low traction soft soled indoor shoes which should be kept clean. They will also need a pair of good fitting light weight leather gloves. Gloves can be purchased at most good department stores.... lightweight unlined gardening gloves work well or mig welders gloves. Gloves can also be purchased at our school.... however supplies are limited at any one time. Students should bring clothes they can move in and a long sleeved shirt for fencing in. Sweatpants or yoga pants are highly suggested as your child will need to be able to move.

Children should pack a lunch or bring money to buy food at the Subway in our parking lot.

Jeff Richardson - Instructor at Arms at Academia Duellatoria

Mr. Richardson has been studying and teaching martial arts since the age of 13 and began studying fencing in 1986 under Olympic coach Michael D'Asaro and Gay Jacobson. In 1993 He began studying Historical European Weapons Systems from surviving treatises on the use of the rapier. He earned his black belt in 1995 in American Open Style Karate under hall of famer Hanshei Jerry Piddington. In 2001 Jeff hosted the first summit on historical Destreza and also began studying sword and buckler and longsword from historical Italian Texts. Mr. Richardson has been a longstanding member of the SCA and holds the title of Guildmaster in the Royal Guild of Fence and apprenticed as an armourer to Richard Tappan. Academia Duellatoria has been an education resource at OMSI and in public and private schools and at various festivals ever since its foundation, and helps with the Tall Ship Royaliste.

Chad is a student at Academis Duellatoria in Italian historical fencing traditions. In addition he is an active participant in historical reenactment. As a student of metal working he has been assisting Academia Duellatoria at events at OMSI by running our metal working demonstrations.
